Commodore: Phil - Thanks to Wes Hula for all of the work on the docks, Kurt Hafferman for overseeing the clubhouse repairs, Jed Vallings and people who helped on the mast-up support. Ron Robison helped out too with fallen trees. Thanks toKen Yackachek for storage, the Switzers for creating a new race series, and Maren for her service at Treasurer. Eleven members joined the club this year. Our docks account has quite a bit in it right now - 38,000. Our docks are not new anymore and are due to need boards replaced. We can either wait until it all needs to be replaced or start maintaining them every year. We've averaged spending 14,000 a year on docks. Property taxes have gone up. Income has not gone up. We have not had a dues increase for 10 years. The clubhouse has averaged 17,000 per year on repairs in the last four years. There are many repairs that need to be done next year. The north property line needs to be filled in. The south ramp needs repair. Our insurance has gone down. Payroll has gone up. Our facilities reserve has gone down. We've been cutting our budgets. The board is looking at raising dues for next year around 100 dollars if you are a slip owner but not on A-dock. Dues will go up 50 dollars.

Vice Commodore: George – Thanks to everyone for their help during the race season. Welcome to the new members. Thanks to the board.

Rear Commodore: Kirk – We've had an expensive year with the clubhouse repairs, and mast hoist repairs. Eric and Wes Hula have been a big help. We have a lot of work coming up. The grill area is sinking. It's dropped 4 or 5 inches. The only way to fix it is to dig it all out and redo it from underneath. It has been a good season. Thanks to everyone for your help. Kirk got a new lawn mower. He would like to see us build a shop.

Treasurer: (See attached report) If interest rates go up, it will affect our loan payment. We make a once a year payment. We are full at 140 members.

**New Business:** 

- 1. By-law Change Proposed By-law Amendment Article XII Section 4
- 1. The yacht grounds are not intended to be a long-term storage area for members' sailboats not being put into the lake and/or their families may store a sailboat on the grounds for the term not to exceed 18 months due to a situational change to the member (e.g. death of the member, major illness, change of job location, or purchase of a new sailboat) unless approved by the Board of Directors. The member will be charged the usual mast up fees for one season and then the sailboat will need to be removed from the yacht club grounds prior to July 1st of the second season of none use.
- 2. No sailboat hardware or accessories (e.g. jack stands, anchors, sails, and masts) may be stored on the grounds unless attached to the sailboat or trailer thereof, unless approved by the Board of Directors. Empty trailers are to be relocated to the trailer storage area.

Sailboats or other miscellaneous equipment that have been abandoned or left on the grounds by a member not in good standing will be disposed of through the accepted legal process.
